Administrative Reports:

Mr. Hanson commented that the crew has been working lots of overtime since winter began and with the complexity of the weather switching back and forth between snow and freezing rain they have been almost nonstop. He explained the process of using the carbide blades for scratching the gravel roads and spoke about the new brine process implemented on trunkline roads and that they are looking into options for brining with a smaller truck for the county roads. He stated that the shop is doing a good job keeping up with the services and that Keith is working on the project list for this year.

Mr. Leggett commented on the sacrifice of the crew working the number of hours they do and that it does not go unnoticed and he extended a Thank You for all they do.

Mr. Jurik echoed Mr. Leggett's comments and stated he appreciates their effort.
