## Install In-floor heat and pour Concrete floors in new building

All submitted bids must be in a sealed envelope clearly marked: **Install In-floor heat and pour Concrete floors in new building.**

All materials and all work will be in accordance with the 2020 MDOT Standard Specifications for Construction. Contractor responsible to comply with all building codes and secure all necessary permits. Insurance requirements shall be in accordance with the 2020 MDOT Standard Specifications for Construction. Award is contingent upon board approval.

## Install In-floor heat and pour Concrete floors in new building.

This Work Must be completed by November 1, 2025.

## **Project Location:**

Project is located at our main Garage at 85 M-115 in Boon township, Wexford County, Michigan The location of this project is behind the main garage in the new pole building near the salt shed.

## **Description of Work:**

The contractor shall pour a concrete floor into our new storage building and approaches and overhang.

## **Project Schedule:**

This project is to be completed prior to **November 1, 2025**. No work on Saturdays, Sundays, or holidays. In the event of a Labor Dispute, lockout, or strike, there will be no extensions of time and liquidated damages will begin on **November 1, 2025**, if the project is not completed.

## **Project Notes:**

- 1. **Building Floor-** The inside of the building (38'x130'x6") will need 5000 psi reinforced concrete with a linear floor drain (removable grates with galvanized runners) in the center of the building with wire mesh in it running length ways down floor for 1' x 80'. Need to provide an insulation between the floor slab and the exterior of the building.
- 2. **In Floor Heating-** Bidder will also have to install in-floor heat in the building floor (38ft x 130ft). It will need to be worked around the floor drain (1'x 80') and kept 1 ft away from the floor drain. Must have vapor barrier and 2" insulation high density PEX Board installed. Contractor must provide a design for approval prior to installation. Design shall include how many zones, tubing size, manifolds pumps, and layouts. Tubing size and max run length shall conform with PEX recommendations of ½" 300' max length 5/8" max length 400' and ¾" 500' max length will depend on the specific designs. All voids shall be foamed.
- 3. **Overhang-** Then off each side pour a 15 ft slab under the overhang. Will need 5000psi reinforced concrete, dimensions are 15'x150'x6".
- **4. Approaches-** approaches at each end of the building dimensions are 68'x10'x6" radiused on each corner, will need 5000psi reinforced concrete.

## **Insurance Requirements:**

Insurance: Proof of Liability and workers Compensation Insurance.

#### **General Note:**

Contractor responsible for complying with all building codes and standards as well as secure all necessary permits. This project is not a Davis/Bacon project, nor does it require prevailing wages to be paid to the contractor or its employees.
