Mr. Hanson stated he had met with NRCS, Trout Unlimited, CRA, GTB and USFS and they many have additional funding to replace 2 culverts in Wexford Township.

Mr. Hurlburt stated that the brining operation started today and that the contracted counties (Wexford, Hanover, Cedar Creek and Liberty) have been completed.

Mr. Hurlburt also stated that MDOT will award \$90,000 in drainage improvements.

Mr. Cooper stated that this winter season he received the most positive comments on the conditions of the road than previously.
