Public Comment: Toby Danford stated that the 37 Rd & 32 Rd. intersection was very dangerous, drivers were running the intersection, there have been 2 close calls since the fatality, 714 people have signed the petition for improvements to the intersection. Their group has Selma & Haring Townships support. They are disappointed as taxpayers nothing has been addressed.

Casey Danford stated there was no clarity on the corners, people were driving 70-80 mph, visibility was poor, needs a flashing light, 4 way stop or rumble strips.

Amy Gonzales feels it's a small ask to have improvements to the intersection.

Steve Salladay was the 1st responder on the scene and suggested rumble strips.

Ryan Gregory stated he's had close calls and his wife is scared of the intersection. S. 37 Rd. has terrible visibility on the left-hand side.

Don Danford stated he sees a lot of distracted driving and people need to focus.

Debra-Ann Brabazen stated due to human behavior, reckless speeding, driving under the influence it is hard to keep the rest of the community safe. It's hard to change human behavior. Regardless of the condition of the driver, would like help to make the intersection more visible.

Brad Slater inquired on the brine wells used by Wexford County and stated that Pleasant Lake was dusty this spring.
