
Public Comment: None.

Approximately 5.52 miles  
MDOT Contract # 2018-0526**

**WHEREAS, The Road Segment, (Old US 131 from 0.035 miles south of the southbound US-131 to the south city limits of Manton) is in the County boundaries and is no longer functioning as a State Trunkline and**

**WHEREAS, MDOT and the Wexford County Road Commission currently have in force a County Trunkline Maintenance Contract for State Trunkline located within the County boundaries and**

**WHEREAS, MDOT agrees to transfer jurisdictional control of the Road Segment to the Wexford County Road Commission and make the modifications to the current Trunkline Maintenance Contract to reflect the Memorandum of Understanding and**

**WHEREAS, In accordance with MCC 247.852, the parties agree that the ROAD SEGMENT is not in need of renovation, repair and/or reconstruction and**

**WHEREAS, The parties agree that the jurisdictional transfer of the ROAD SEGMENT complies with the provisions of MCC 247.851 et. Seq. and**

**WHEREAS, The Wexford County Road Commission agrees to assume full jurisdictional control of Road Segment as stated in the Memorandum of Understanding , making the Road Segment a County Primary road.**

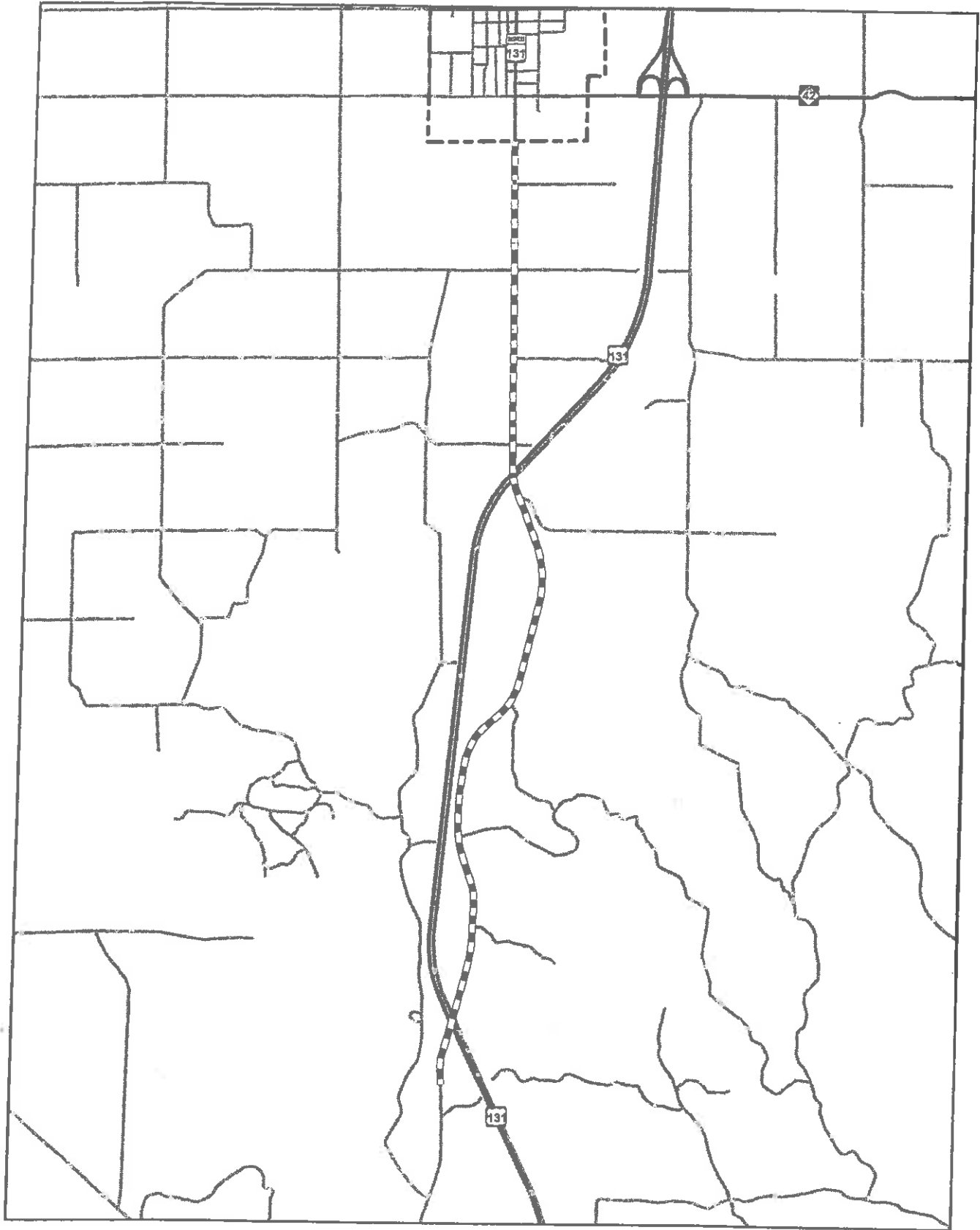
**NOW THEREFORE, BE IT RESOLVED that the Wexford County Road Commission Board approves the Memorandum of Understanding, transferring the jurisdictional control of Old US 131 from 0.035 miles south of the southbound US-131 to the south city limits of Manton from MDOT to the Wexford County Road Commission, and authorizes the Manager, Alan D. Cooper to sign MDOT Contract NO. 2018-0526 and any documents related to the jurisdictional transfer.**
