The Crumb rubber Chip seal projects are planning to start next week while the prep work of wedges and skip patches in preparation for that are just about finished. There is lots of work for MDOT this year with a large shoulder project on M-55. The crews are currently doing allot of work for the USFS and that is going well. Mr. Hanson gave an update on the tractor fire concerns and other tractor fires that occurred in the area recently. Mr. Hanson updated the board on the status of brining of gravel roads.
